Objective

I am pleased to submit my application for the Library Advisory Board (LAB). Although it's been less than five years since I moved to Citrus County full-time, my very active community and civic involvement, along with my extensive background in government service, elected leadership roles and public affairs reporting, have uniquely prepared me to be a positive and effective addition to this board. In the last four and a half years, I have made significant positive contributions to the county's library system, including spearheading the successful campaigns to end the annual "LGBT Pride" propaganda displays in the libraries and terminate the county's membership in the American Library Association, which sparked the subsequent statewide push to defund the ALA over its Marxist LGBT grooming agenda. I was also part of the effort to expose the existence of LGBT pornographic books in the library system's teen section, which led to the removal of the filthy LGBT teen novel "Jack of Hearts (and Other Parts)" from the system. Most recently, I led the campaign to end the county library system's \$3,300 subscription to BookPage and its woke pro-LGBT, pro-abortion, pro-CRT, pro-witchcraft and anti-Trump agenda. I have been a dues-paying member of the Friends of the Library in the Lakes Region and Florida City libraries. If appointed to the LAB, I pledge to dedicate my service to focusing on the library system's core mission of promoting literacy while preserving community standards, keeping in mind our community's wholesome, family-friendly, God-fearing Christian values.
